# **Project Title**

Supporting academics with inclusive & equitable curricula, teaching and learning (Follow-up Interviews Phase)

## Outline of the project

**Description and Methodology:** The purpose of this study is to advance inclusive and equitable teaching and learning, curriculum, assessment practices and policies. An interview will now be used to encourage academics who previously completed the survey for this project to elaborate on their responses.

**Participants:** To be eligible to participate in this study, you must be an academic teaching staff member working at a higher education institution in Australia, and you must have already completed the survey we previously administered about your understandings of inclusive and equitable teaching and learning, curriculum, assessment practices and policies, and areas of good practice.

**Use of data and Feedback:** If you would like a summary of the study findings to be sent to you at the conclusion of the study, please request this from a member of the research team. The research team also intend to publish and report the results of the research. All information will be published in a way that does not identify you. If you would like the opportunity to review the transcript of the interview, please request this from a member of the research team. You can then request changes to the transcript if required. The research team will only use your contact information for the procedures outlined above.

**Project Funding:** This study is funded by an Australian Centre for Student Equity and Success (ACSES): 2025-26 Large Grant Research Round.

# Participant Involvement

**Voluntary Participation and Withdrawal:** Participation in this study is entirely voluntary. You may decline to take part or withdraw from the research without providing an explanation at any time until data collation and analysis has commenced. You can refuse to answer questions in the interview. Your decision not to participate or to withdraw will not affect your relationship with the Australian National University, or any other participating organisations. If you decided to leave the research study, no additional information will be collected from you. If you wish to withdraw, you can do so by emailing the research team and telling them that you no longer want to participate.

What does participation involve: If you agree to participate in this study, you will be asked to take part in a one-to-one interview with a member of the research team. This interview will be unstructured and will draw on analyses of some of the high-level aggregated responses that have been received for the survey.

**Location and duration:** Interviews will take approximately 30 minutes and will take place online (using Microsoft Teams). To ensure that your responses are collected accurately, we seek your permission to digitally record the interviews. Microsoft Teams software will be used to generate an automated transcript of the discussion. Audio and video data will be destroyed after the accuracy of the transcript has been checked. If you would like to participate but do not wish to be recorded, please discuss your participation options with the research team.

Remuneration: There are no costs associated with participating in this research.

**Risks:** The research team do not anticipate that participating in the interview will cause you any distress or harm. If participation in this research does cause you to become upset or distressed, the research team recommend that you contact the free support service included later in this form. Any counselling or support will be provided by qualified staff who are not members of the research team and will be free of charge.

**Benefits:** While the research findings may not directly benefit you immediately, your involvement will contribute to policy, professional development, and practice recommendations for academics in Australian universities to operationalise inclusive curricula and teaching and learning approaches (e.g., practical strategies in the classroom and a professional development schedule).

# **Confidentiality**

The research team will make every attempt to keep your data confidential. Your personal information will be pseudonymised and stored securely, and the research results will be published in a way that does not identify you (i.e., using a pseudonym). Only members of the research team will have access to your data, and it will not be shared with anyone outside of the study unless you consent to this for the purposes of future research. In the interview, we ask that you do not make statements of a confidential nature or defamatory statements about any person.
